#### Question:

Is it possible to issue an EC Type-Examination certificate (as defined in Annex III of Directive 94/9/EC) for Category 3 products. This would be achieved by application of Annex III EC Type-Examination to Category 3 products, at the request of the manufacturer?

#### Proposed Answer:

It is not possible to issue an EC Type Examination Certificate for Category 3 products. However, the voluntary issue of a Type Examination Certificate is possible for products covered by Annex VIII. A suitable template of this certificate is attached.

The certification body may not give an indication on the certificate that it is an NB as it would not be acting in that capacity.

There is no objection for the hexagon to be used.

### Rationale

Although it may be considered as a private matter, if certificates are to be issued for products covered by Annex VIII-Internal Control of Production, then these certificates should be in a commorn, consistent format followed by all members of ExNB.

This EXNB interpretation/Clarification Sheet has the sole purpose of clarifying the application of the EN Standards and/or of the requirements of Directive 9419/EC and related documents. It does not in any way change the content of the standards and/or of the requirements. It remains valid until an official answer is received from the European Commission or the relevant standardization bodies.
